In 1998, the federal government passed the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, or the Clery Act. As a recipient of Federal Title IV student financial aid, The Institute for Clinical Social Work is required to adhere to The Jeanne Clery Disclosure of Campus Security Police and Campus Crime Statistics Act (The Clery Act). One of the provisions in the Clery Act is for all postsecondary institutions receiving federal Title IV financial aid to publish an annual report disclosing the three most recent years of selected crime statistics.

Requirements of the Clery Act:

- Issue an annual security report that discloses campus crime statistics for the preceding 3 calendar years to current and prospective students, employees and the U.S. Department of Education.
- Advise students and employees of Clery crimes and issue timely safety warnings and emergency notifications for crimes that pose a serious or continuous threat to the campus community.
- Include policy statements regarding (but not limited to) crime reporting, campus facility security and access, law enforcement authority, incidence of alcohol and drug use, and the prevention of/response to sexual assault, domestic or dating violence, and stalking.
- Maintain a public, daily log of reported crimes.
- Details on the university efforts taken to improve campus safety. The purpose of the Clery Act is to provide current and perspective students, and employees with accurate, complete and timely information about campus safety so that they can make informed decisions.
